RE: 2024 FARMER SAP Project Award Recommendations

Dear Julie Hunter:

The Placer County Air Pollution Control District (PCAPCD) is pleased to announce the FARMER Shared Allocation Pool (SAP) project award recommendations for the 2024 solicitation. As always, this year’s solicitation was extremely competitive. In total, the SAP received over 135 applications for review which, if funded at their maximum award amount, would total roughly \$13.5 million in funding. In contrast, the CARB FY 23-24 project fund allocation for the FARMER SAP was \$2,719,242.00, about 20% of the Pool’s total requests for this year. The PCAPCD is actively working with CARB to secure additional FARMER funding and will contact your district if a waitlisted project is selected for funding.

A list of your district’s submitted project(s), award status, and recommended funding amount is attached to this letter. **It is the responsibility of each district to contact project applicants regarding their award status.** You must respond to PCAPCD confirming your applicants’ intent to accept the award **within 30 days** of the date of this letter in order to secure the funds.

Your district’s project coordinator should mark “Accept”, “Decline”, or “Amend” on the attached recommended projects list and insert their initials confirming the selection(s). If you would like to request an amended project award amount, the Amended Amount Requested column(s) should be completed. Amended project awards are subject to additional approval by PCAPCD. PCAPCD will assume a district has declined all funds on behalf of their applicants if a response is not received by the deadline.

Grant Disbursement Request Forms may be submitted with electronic signatures by email (fillable PDF form available for download on the Grant Resources Page at: <https://farmer-grant.force.com>, or upon request). Final disbursement requests must be received by PCAPCD no later than one (1) year after the Project Award Date of October 25, 2024. The CARB FY and liquidation deadlines associated with the project awards will be provided upon the approval of your district’s grant disbursement request(s).
