Chair Adams called the meeting to order at 1:01 P.M. A guorum was confirmed. Also present; Gretchen Bennitt, Executive Director; Melissa Klundby, APCSII, Dawn Lunsford, Clerk of the Board, Mikki Brown, Federal TAG Specialist I, Tasha Coleman, APCS I, Ray Kapahi (public comment), Leah Mathews (CARB)

Chair Adams called for public comment for items not appearing on the agenda. There was no public comment.

### III. Approval and/or modification to the agenda

Chair Adams asked if there were any requested modifications to the agenda. Hearing none, Supervisor Roen made a motion to approve the agenda as presented Supervisor Bullock seconded the motion. The motion was approved unanimously with a roll call vote.

### IV. Consent Calendar

Supervisor Roen made a motion to approve the consent calendar. Supervisor Bullock seconded the motion. The motion was approved unanimously with a roll call vote.

V. Administrative Report

**A.** Public Hearing and Proposed Adoption of Air District Rule 230 – Architectural Coatings

Ms. Bennitt requested that this item be cancelled for now, due to comments received from the public that substantially changed the rule. Ms. Bennitt discussed that she plans to make modifications to the rule based upon public comment. She will be releasing those changes to the public for further comment and have a public hearing when this revised proposed rule is brought before the Board in the future.

**B**. Public Hearing and Proposed Adoption of the Ozone Attainment Plan for Western Nevada County (2023 Plan) for the 70 parts per billion 8-hour ozone standard (70 ppb ozone standard).

District staff has developed the Ozone Attainment Plan for Western Nevada County (2023 Plan) for the 70 parts per billion 8-hour ozone standard (70 ppb ozone standard).

The California Air Resources Board staff has concluded that the 2023 Plan meets the State Implementation Plan (SIP) planning federal requirements of the federal Clean Air Act including attainment demonstration, emissions inventory, reasonable further progress (RFP), reasonably available control measures (RACM) analysis and transportation conformity demonstrations, and contingency measures for progress and attainment.

Staff released the SIP and all of its appendices in a public notice prior to this hearing.

Chair Adams opened the public hearing. The following are the comments received:

Ray Kapahi, Air Quality Consultant – He had comments related to the ozone precursor emissions inventory.

He discussed that Section II (E) indicates that emissions of ROG from stationary, mobile and area sources represent only 6.6 tons/day while natural sources are estimated to equal 215.6 tons/day. This means that natural sources represent 97% of all ROG emissions.

In other words, the State or the District has no control over 97% of the ROG emissions. What is the point in regulating ROG emissions from gasoline dispensing, consumer products, aerosol coatings and petroleum storage? Even if emissions from these categories were eliminated, there would not be any meaningful change in the overall ROG emissions budget for the County.

Since ROG is one of the 2 main precursors for ozone (NOx being the other), is it the District's position that reducing NOx emissions will be sufficient to bring the region into attainment for the 2015 ozone standard?

**Leah Mathews, California Air Resources Board** – Leah commented that CARB is in full support of passing the SIP and has every confidence that the Air District will make attainment. There have been many steps in this process and the Air District developed documents that have been included in the SIP. CARB supports this proposal.

Chair Adams closed the public hearing.

Supervisor Bullock made a motion to approve the SIP by authorizing the approval of Resolution 2023-04. Supervisor Scofield seconded the motion. The Motion was approved unanimously with a roll call vote.

**C.** Appoint Nevada County Supervisor Hoek as an alternate to Mountain Counties Air Basin Control Council (BCC)

Northern Sierra Air Quality Management District is a member of the Mountain Counties Air Basin, which consists of 7 foothill air districts – Northern Sierra, Placer, El Dorado, Amador, Calaveras, Tuolumne and Mariposa air districts, respectively. The Mountain Counties Air Basin Technical Advisory Committee (TAC) meets regularly and is composed of staff members from each air district. Annually, the Mountain Counties Air Basin Control Council (BCC) meets to provide guidance and leadership for the TAC. The BCC is comprised of an air district board member from each of the air districts. Currently, Supervisor Adams is the appointed BCC member for Northern Sierra, but an alternate is necessary. Nevada County Supervisor Hoek (and alternate Air District Board Member) has expressed a willingness to represent the Air District on the BCC as an alternate.

Supervisor Scofield made a motion to appoint Nevada County Supervisor Hoek as an alternate to Mountain Counties Air Basin Control Council (BCC). Supervisor Bullock seconded the motion. The motion was approved unanimously with a roll call vote.
